香港冰球協會（HKIHA）正式公佈香港女子冰球代表隊（HKWNIHT）將會參加 2015 年國際冰球聯合會亞洲冰球挑戰盃（在台灣舉辦）和 2015 年國際冰球聯合會世界女子冰球錦標賽第二組別 B 組資格賽（在香港舉辦）。

本會很感謝所有參與 2013/2014 香港女子冰球代表隊活動計劃的球員，隨著香港於冰球世錦賽首次亮相，香港女子冰球代表隊亦能於首個賽季取得目前世界排行第 37 位，這是一個好的開始及奠定了重要的根基。

有著目前和未來的球員的幫助和貢獻下，本會有信心繼續成長並在香港發展女子冰球。而在香港女子冰球代表隊活動計劃中，本會將會挑選三十位球員，有望致力進行計劃，以及協助香港青年發展計劃。

香港將會參與在台灣舉辦的 2015 年國際冰球聯合會亞洲冰球挑戰盃（2014 年 11 月 - 日期待）及在香港舉辦的 2015 年國際冰球聯合會世界女子冰球錦標賽第二組別 B 組資格賽（2015 年 2 月 18-22 日）。

有關費用不需立即付款，一旦您已遞交申請以及參與選拔賽，球員將會將被選中到參與 2014/2015 香港女子冰球代表隊活動計劃，屆時將會收取費用，是次活動計劃將會挑選三十名球員。

申請截止日期：2014 年 8 月 15 日（星期五）下午 5 時（香港時間）

如果您不在香港，您可以透過電子郵件申請。所有相關文件必須在 2014 年 8 月 15 日（星期五）下午 5 時（香港時間）之前送交到香港冰球協會。您的申請將由香港冰球協會之執行委員會委員研究，他們將自行決定是否會接受您的申請與否。

如果您持有超過 1 個國籍，您在被允許參加世界錦標賽/亞洲挑戰盃之前，需要先通過國際冰球聯合會資格檢查。請參閱以下有關國際冰球聯合會資格檢查之程序，在此期間，您須要先遞交申請，一旦執行委員會已接受了您的申請，我們將會處理您的資格檢查及程序，並向國際冰球聯合會提交文件。

若參加者有興趣，但只持有香港身份證及合乎資格取得香港特區護照，您仍然可以申請，您必須申請香港特區護照後，才合資格參加任何賽事。

若參加者有興趣參與任何活動，請及時提交您的申請表格。這將不收取任何費用，所有必需費用及時間表將稍後時間公佈。

持有超過 1 個護照的球員

如果您擁有超過 1 個國籍，國際冰球聯合會將尋找下列文件，然後才能代表香港冰球代表隊出賽：

如果一個球員擁有或曾經擁有一個額外的公民身份或擁有多重國籍，她必須證明她曾參加連續性的聯賽，參與至少一個冰球賽季及至少連續 12 個月是本會成員。

因此，按照國際冰球聯合會規定每個多國籍球員必須呈交下列文件：

- 由父母雙方申報居留期間所涉的宣誓書
- 確認球員的新國家協會宣誓書的簽名和蓋章，並參與之指定確實日期
- 期間由市政府蓋印及簽署的居留證件
- 期間所涉的學校記錄
- 期間所涉的比賽核准表（每個賽季從開始，中段和結束 共 3 張）
- 期間確認在校出席率的校長簽名學校原信紙

請注意，所有這些文件都必須互相配合，這表示各自提供的相應時間須超過 730 日（如 2002 年 6 月 18 日 - 2004 年 8 月 24 日）

HongKong Ice Hockey Association (**HKIHA**) is proud to announce that Hong Kong Women's National Ice Hockey Team (**HKWNIHT**) will participate in the 2015 IIHF Challenge Cup of Asia (in Taiwan) and 2015 IIHF Ice Hockey Women's World Championship Division II Group B Qualification (in Hong Kong).

We are grateful to all the players who participated in the 2013/2014 HKWNIHT program. With Hong Kong making its first debut to the world, it was a good start in the inaugural season with HKWNIHT now being ranked 37 in the world

With the help and contribution from the present and future players in the HKWNIHT program we are confident that collectively we shall continue to grow and to develop women's ice hockey in Hong Kong. By doing so, the 30 selected players who will be part of the 2014/2015 HKWNIHT program will be expected to be committed to the program as well as to help the youth development program in Hong Kong.

Hong Kong will be participating in the 2015 IIHF Challenge Cup of Asia in Taiwan in November 2014 (Date(s) to be confirmed) and 2015 IIHF Ice Hockey Women's World Championship Division II Group B Qualification in Hong Kong (18 – 22 February 2015).

Applications are now open to all women hockey players who wish to participate in 2014/2015 HKWNIHT program.

As we are currently looking for sponsors, there is minimal/no funding for HKWNIHT program at this juncture in time. In this regard, players who are accepted into the program will need to contribute HK\$4,000 for the above mentioned on ice training. Should there be less funding from sponsorship there could potentially be extra costs pending availability of extra training facilities, flights for CCoA etc.



ELIGIBILITY:

Female Players with HKSAR passport only
Player born in 1999 or earlier with valid HKSAR passport
Player born 1997-1999 are underage player, requiring signed underage waiver by parent

No payment will be necessary at this moment. Once you have applied and have attended try outs, players will be selected onto 2014/2015 HKWNIHT Program at which time payment will be collected. A total of 30 players will be part of the program.

APPLICATION DEADLINE: FRIDAY, 5 P.M. (HONG KONG TIME) 15TH AUGUST 2014

If you are out of town, you can apply through email. All the proper documents must be sent to HKIHA before Friday, 5 p.m. (Hong Kong Time) 15th August 2014. Your application will be considered by the Executive Committee members and they will decide whether they will accept your application or not.

If you have more than 1 nationality, your eligibility to play will need to go thru the IIHF eligibility check before you are allowed to participate in the World Championships / Challenge Cup. Please see below for more details about IIHF eligibility check and what the process is before you will be allowed to play. In the meantime, you will need to submit your application first, once you have been accepted by the Executive Committee, we will process your eligibility with IIHF which will required you to provide the proper documents accordingly.

If you are interested but you only have HKID card and eligible to obtain a HKSAR passport, you can still apply and you must obtain your HKSAR passport to be eligible to play at any of the tournament.

If you are interested to play at any of the events, please submit your application form on time. There will be no cost to you going through this process. All the necessary cost and schedule will be announced accordingly. There is no commitment at this point.

PLAYERS WITH MORE THAN 1 PASSPORT

If you have more than 1 nationality, IIHF will be looking for the following documents before you can play for HKSAR National Ice Hockey Team:

If a player has or has ever had an additional citizenship or has multiple citizenships she must prove that she has participated on a consistent basis, for at least one hockey season and have been member of the new national association for at least 12 consecutive months during that period.

Therefore the following documents needs to be submitted for every multi-national player according the IIHF Regulations:

- *An affidavit from both parents declaring residency for the period in question*
- *Signature and stamp on a affidavit from the new national association confirming participation by this player and specifying the exact dates of participation*
- *Stamped and signed residency papers from the municipality for the period in question*
- *School records for the period in question*
- *Approved game sheets for the period in question (3 per season from the beginning, middle and the end)*
- *School principal signature on original school letterhead confirming attendance in their school for the period in question*

Please note that all of these documents must match each other which means must be provided for the respective time frame for over 730 days (e.g. 18.06.2002 – 24.08.2004).

Security of Property

The Event Venue or Hong Kong Ice Hockey Association Limited ("HKIHA") will not be responsible for the loss or damage of the applicant's property either before, during or after the event. It shall be the responsibility of each applicant to provide his own security.

Loss, Injury and Accidents

Neither the Event Venue or HKIHA, will be responsible for any injury, accident to person, or loss of property inside the Event Venue and their respective loading docks, or surrounding area.

Use of the ice surface is entirely at the risk of the applicant. Accidents occurring on or off the ice will be the responsibility of the applicant and it is therefore suggested the applicant consider his own insurance coverage. This application constitutes a contract between the applicant and HKIHA, and a release liability to HKIHA, its executive committee, for anytime before, during or after games or practices organized by HKIHA. Each applicant is bound by the terms hereof.

Declaration

I for myself, my executors and administrators, do hereby waive and release any and all rights, claims and causes of action I have or may have against Hong Kong Ice Hockey Association and all sponsors, promoters, supporters and all other contributors from any and all liability arising from accident, illness, injury, death, loss and economic consequences I may suffer as a result of my entry in this event from any cause whatsoever, including negligence. I certify that I am physically fit and sufficiently trained to complete for the competition of this event.
